## **Installation Instructions**

**1992–95 325 / M3 (exc. Lightweight) / 525 / 530 / 535 (w/Valeo Alternator)**

*Part# 040201202 contains crank pulley Part# 0202102. accessory pulleys: alternator Part#0102312, power steering Part# 0102402, water pump*

*Part# 0102502 and a timing ring with 5 bolts. Timing ring comes pre-mounted. CHECK TIMING RING BOLTS ARE TIGHT. Check part numbers*

*match numbers engraved on back of pulleys. If numbers or qty of parts don't match, stop install and call your dealer or our tech line.*

- **Notice:** *These instructions are not a replacement for the factory manual; factory specified tools maybe required for removal of the original parts.*
- Open hood then raise front of car and place jack stands on passenger and driver side frame rails.
- Remove plastic intake assembly from air filter housing all way to throttle body.
- Unbolt and remove fan from water pump, leave fan inside shroud assembly. Fan threading to water-pump nut is a reverse thread.
- Loosen six crank pulley bolts slightly, do not remove yet then loosen alternator, water pump and power steering pump pulley bolts, do not remove yet.
- Loosen and remove belts and air conditioning tensioner assembly (remember belt routings).
- Remove crank, alternator, power steering and water pump pulleys.
- Very lightly coat bore of alternator and rear of crank, power steering and water pump pulleys with anti-seize compound. Make sure all mounting surface edges have no burrs. If none are present pulley will slip on and seat properly. **Do not force the pulley onto the mounting surfaces as damage to both will occur voiding warranty.** If pulleys are tight clean surface/edges (they get slightly rusty) with emery cloth until pulleys slide on.
- Install crank, alternator, power steering and water pump pulleys then tighten bolts and nuts hand tight.
- Tighten crank pulley bolts in an opposing pattern for equal torque distribution. (See torque specification below)
- Replace belts and re-install remaining components in reverse order (see necessary new sizes below).
- Raise car then remove jack stands and lower car back down.
- The maximum HP gains will occur within 5-7 days of installation, once the computer recalibrates to take advantage of the engines lighter rotational weight.

### **Torque Specifications**

- Crank Pulley Bolts: 19-24 ft-lbs. / 228-288 in-lbs. / 26-33 NM <> Timing Ring Bolts: 8-12 ft-lbs or until lock washer is fully crushed.

**New Belt Sizes** (UR sells Gates belts at [www.unorthodoxracing.com](http://www.unorthodoxracing.com). Belt sizes used may vary slightly. Belt sizes can vary from belt manufacturer to belt manufacturer)

- Alternator, Power Steering and Water Pump Belt: Use Gates K060594.
- Air Conditioning Belt: Use Gates K050330.

**Belts must be changed every two years because belt rubber may harden enough to cause damage to the pulley/s.**  
**Keep your belt purchase receipts as they are required for any warranty claims sent to UR.**
