Installation Instructions

1997-02 A4, A6 & S4 2.7T / 2.8L, 1998-02 Passat 2.8L (w/Valeo Alternator)

Kit# 041401702 contains crank Part# 0214107, alternator Part# 0114317 & power steering Part# 0114407. Check part numbers match part number engraved on pulleys. If part numbers or quantity of parts don't match stop and call dealer you purchased from or call our tech line.

- **Notice:** *These instructions are not a replacement for the factory manual; factory specified tools maybe required for removal of the original parts.*
- Raise hood then put front end into service position (procedure is outlined in detail in factory manual).
- Raise front end of vehicle and secure with a jack/ safety stands then remove lower engine compartment plastic shrouding.
- Loosen 8 bolts on crank pulley but do not remove yet then loosen 3 bolts on power steering pulley and nut on alternator pulley but do not remove yet.
- Loosen and remove accessory drive belt with factory auto tensioner then remove original crank and accessory pulleys.
- Lightly coat bore of alternator pulley and rear of crank and power steering pulleys with anti-seize compound.
- Install underdrive crank pulley and tighten bolts (see torque specification below). Make sure crank snout edge has no burrs, if none are present pulley will slip on easily and seat properly. **Do not force pulley onto crankshaft, as damage to both will occur voiding warranty.** In rare case pulley is tight clean crank snout (they can get slightly rusty) with emery cloth until pulley slides on as stated.
- Install new alternator & power steering pulleys then install new belt (see size below).
- Re-install remaining components in reverse order then put front end in normal position, raise car and remove safety stands.
- The maximum HP gains will occur within 5-7 days of installation, once the computer recalibrates to take advantage of the engines lighter rotational weight.

New Belt Size (UR sells Gates belts at www.unorthodoxracing.com. Belt sizes used may vary slightly. Belt sizes can vary from belt manufacturer to belt manufacturer)

- Air Conditioning, Alternator & Power Steering Belt - Gates K060716 (72" or 1830MM)

Belts must be changed every two years because belt rubber may harden enough to cause damage to the pulley/s.
