- Performance clutch kits (Ultra G) available for all models, kits include pressure plate, disc, required bearings and an alignment tool.
  - Full faced Kevlar disc holds 30% more power than the stock clutch (Solid or sprung hub disc). (Street Sport) For stock to slightly modified cars.
  - Windowed Kevlar disc holds 45% more power than the stock clutch (Solid or sprung hub disc). (Sport Mod) For slightly to moderately modified cars.
  - Four or Six (6) paddle Ceramic disc holds 80% or Feramic discs holds 110% more power than the stock clutch (Solid or sprung hub disc).  
Ceramic (Sport Pro) for moderately to heavily modified cars and Feramic (Race Pro) is designed for heavily to race modified cars.

### Installation Instructions

#### **1994-97 Mazda Miata / 1992-95 Mazda MX-3 / 1996 Ford Escort**

- **Notice:** *These instructions are not a replacement for the factory manual; factory specified tools maybe required for removal of the original parts.*
- Open the hood to gain access to the engine compartment.
- **Miata Only:** Remove the air intake hose assembly for easy access to the belt tensioners and original crankshaft pulley bolts.
- **MX-3 / Escort Only:** Loosen the passenger side front wheel lugs / nuts.
- **MX-3 / Escort Only:** Raise the passenger side front of the vehicle and secure with jack / safety stands and remove the wheel.
- Loosen the crankshaft pulley bolts but do not remove yet.
- Loosen and remove the air conditioning / power steering belt, then loosen and remove the alternator / water pump belt.
- Remove the loosened crankshaft pulley bolts and remove the original crankshaft pulley.
- Install the underdrive crankshaft pulley, lightly coat the inner bore and the back of the new pulley with anti-seize compound and tighten the pulley bolts, see bolt torque specification below. Make sure that the crank snout edge has no burrs, if no burrs are present pulley will slip on easily and seat properly. **Do not force pulley onto crank shaft as damage to both will occur voiding the warranty.** In the rare case that a pulley is tight clean crank snout (as they can get slightly rusty) with emery cloth until pulley slides on as stated.
- Install the new accessory belts in reverse order, see the necessary new belt sizes below.
- Tighten the new accessory belts to factory tension specifications.
- **Miata Only:** Re-install intake hose and plumbing assembly, make sure all hose clamps are properly tightened.
- **MX-3 / Escort Only:** Raise passenger side front of vehicle, install wheels and remove jack / safety stands.
- **MX-3 / Escort Only:** Tighten the passenger side front wheel lugs / nuts to factory specification.
- The maximum HP gains will occur in 5-7 days of installation, once the computer recalibrates to take advantage of the engines lighter rotational weight.

- 9-13 ft-lbs. / 109-152 in-lbs. / 12-18 NM

**New Belt Sizes** (The belt sizes used may vary slightly. We recommend the use of Gates brand belts, sizing varies among belt manufacturers)

- Alternator and Water Pump Belt - Escort, Miata, MX-3: Use Gates K040340 (34 5/8" or 880MM)
- Air Conditioning without Power Steering Belt – Miata: Use Gates K040325 (33 1/8" or 840MM)
- Power Steering & Air Conditioning Belt - Escort, MX-3: Use Gates K040384 (38 7/8" or 985MM)  
Miata: use Gates K040360 ( , alternate belt size use K040365)
- Power Steering Belt without A/C – Escort: Use Gates K040345 (35" or 890MM) / MX-3 use Gates K040340 (34 5/8" or 880MM)  
Miata: Use Gates K040330 33 5/8" or 855MM)

Unorthodox Racing, Inc. warrants the quality of the products it designs and manufactures to be free of defects in material and workmanship for one year from date of purchase for pulleys, cam gears and aluminum flywheels and 90 days from date of purchase for all stages of clutches. This limited warranty is extended only to the individual purchaser who has purchased our product from an authorized reseller and may not be transferred or assigned. A list of authorized resellers is available on our web site or can be obtained by calling our main offices. This limited warranty applies to any product, which, after careful inspection by Unorthodox Racing Inc., after receipt of the product/s from our authorized reseller, is found to have a defect in either material or workmanship. **UNORTHODOX RACING, INC. PARTS, USED IN COMPETITION OF ANY KIND, SANCTIONED OR UNSANCTIONED, ARE SOLD "AS IS" WITHOUT ANY WARRANTY WHATSOEVER.** Any modifications to the pulley/pulleys will void any and all warranties and will not be exchanged. Any claims for clutches must be received no later than 90 days from the date of purchase. If you purchased items directly from Unorthodox Racing Inc., discontinued and blow out items are final sale only, please contact our customer service department, they will issue you a "RETURN MERCHANDISE AUTHORIZATION" number (RMA#).
